

Thank you for your interest in our Academy. A student information packet is enclosed for your use in gaining admission to our school.

To apply at our Academy you will need to submit the following documents:

- 1. The Form A1- **Application for Admission** (must be 18 years or older for admittance, or if under 18 years this form must be signed by parent or legal guardian).
- 2. The Form A2-**Travel, Rental car, Living, and Financial Arrangements.** Include with this form the \$750 refundable security deposit. Payment of this deposit signifies an acceptance of the admission and holds a space for you. Upon physical enrollment, this deposit will be credited towards your tuition.
 - 3. **Transcripts** showing you have completed high school, or equivalent such as GED.

Please note: The U.S. Department of Homeland Security now requires that candidates must provide proof of citizenship in order to attend pilot training. The Transportation Security Administration (TSA) will not allow flight training to commence without proof of U.S. Citizenship in the form of the following documents:

- a) A valid, un-expired United States passport. The passport must remain valid throughout the entire length of the training course.
- b) An original birth certificate, with raised seal, documenting birth in the United States or one of its territories, along with a valid un-expired government issued photo I.D. (such as a drivers license).
- c) An original U. S. naturalization certificate with raised seal (Form N-550 or Form N-570), along with a valid un-expired government issued photo I.D. (such as a drivers license).
- d) An original certificate of U.S. Citizenship (Form N-560 or N-561) or a certificate of repatriation (Form N-581) along with a valid un-expired government issued photo I.D. (such as a driver's license).
- e) A U.S. federal government issued I.D. badge if training for the U.S. government and a U.S. government entity is paying for the training.

Upon inspection a copy of the appropriate document and picture I.D. will be secured in the candidate's administrative folder. Allow two weeks for processing upon receipt of all required documents.
